
# **SCANDALS: WHITEWATER**

Are there recurring public opinion patterns in political scandals? In the next seven pages we look at Whitewater and at the early days of Iran-Contra and Watergate. In March 1994, Americans were still confused about Whitewater. The number who say they are following it closely has risen modestly since January.

Question: Do you approve or disapprove of the way Bill Clinton is handling his job as president?


#### Approve of the way Bill Clinton is handling his job as president


- \* Jan. 20, 1994 -Special counsel selected to investigate Whitewater.




Early on Americans wanted an independent investigator appointed and felt they needed to know more. Tension between wanting aggressive media and the feeling that they have overplayed their roles is apparent in attitudes about Whitewater, Iran-Contra, and Watergate. Clinton has been dogged by questions of trust from the start.

Question: Do you think Whitewater is a serious matter that requires a full-scale federal investigation, or do you think it's not a serious matter and should just be dropped, or what?













Question: Do you think Bill Clinton is a leader you can trust, or do you have some doubts and reservations?





Question: Do you think Bill Clinton is honest and trustworthy enough to be president, or don't you think so?






### **Political Fallout**

Majorities of Democrats and independents say Bill Clinton has been mostly truthful about Whitewater, while majorities of Republicans and independents, in response to another question, say he is hiding something. Solid majorities nationally say Whitewater hasn't affected their evaluation of Clinton.

Question: In your view, is Bill Clinton hiding something concerning his role in these matters, or don't you think so?




From what you have heard or read about Bill Clinton's involvement...





Question: Do you think the Republicans in Congress are overreacting to the Whitewater matter, or are they reacting appropriately?





# IRAN-CONTRA

Ronald Reagan lost all of the support he was going to lose very early in the Iran-Contra scandal. Six in ten were following it closely in November 1986, three-quarters by March 1987. Americans thought there was more to learn and wanted a special prosecutor appointed in this instance, too.


Question: Do you approve or disapprove of the way Ronald Reagan is handling his job as president?




The belief that Reagan wasn't telling the truth about Iran-Contra grew through the spring. A plurality in December and a majority in July said press coverage was about right, but far more said coverage was too aggressive than said it was not aggressive enough. The belief in Reagan's honesty held solidly in the early months of the scandal.







Question: Do you think Ronald Reagan has more honesty and integrity than most people in public life?





# WATERGATE


Watergate took months to emerge in public opinion data. Only a few questions were asked about it in the summer and fall of 1972. By April 1973, nine months after the scandal broke, however, awareness was widespread. At that time, Americans said the White House had witheld information and called for a special prosecutor.





About a year into Watergate, the public began to question whether it was just politics or something more serious. Ambivalence about the press' role existed in Watergate, too. Nixon, unlike Reagan, lost substantial ground on the integrity question early. If a question mentioned the cover-up, Americans favored Nixon's resignation.

Question: Which of these two statements comes closer to your point of view about Watergate?






